**ARTICLES OF ORGANIZATION OF

The undersigned, HARRY B. STACKHOUSE, a natural person competent to contract and an authorized representative of a member of JERRY PATE LEASING, LLC, hereby presents these Articles of Organization as the Articles of Organization of JERRY PATE LEASING, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:

JERRY PATE LEASING, LLC

This limited liability company is referred to in these articles of organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the principal office of the Company is 301 Schubert Drive, Pensacola, Florida 32504.

ARTICLE III - PURPOSES AND POWERS


ARTICLE VIII - RESTRICTION ON MEMBERSHIP
