**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be Costa Apparel, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 731 Duval Station Road, Suite 107-323, Jacksonville, Florida 32218.

**ARTICLE II**

**PURPOSES AND POWERS**

DURATION AND COMMENCEMENT

The Company shall exist perpetually.
