The undersigned person, acting hereby as Organizer for the purpose of forming a limited liability company under the Florida Statutes, Chapter 608, hereby executes the following Articles of Organization:

I NAME. The name of the limited liability company shall be: Reinhart Enterprises, LLC ("Company").

II ADDRESS. The mailing address and street address of the principal office of the Company shall be 10808 SW 27th Avenue, Gainesville, Florida 32608.
