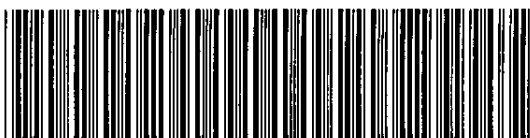

The purpose of which the Company is being formed is to in engage in any activities or business permitted under the laws of the United States and the State of Florida.


ARTICLE IV - ADDRESS


