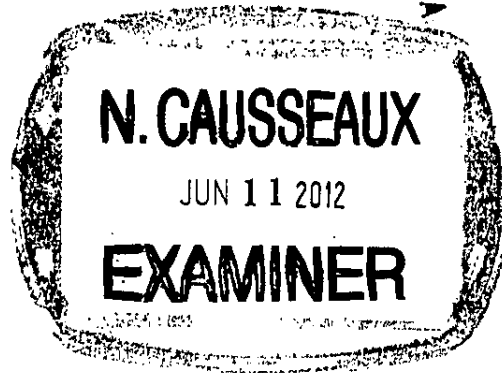

**ARTICLE I  
NAME**

The name of this Limited Liability Company shall be **BARNEY'S BUNGALOW, LLC.**

**ARTICLE II  
DURATION**

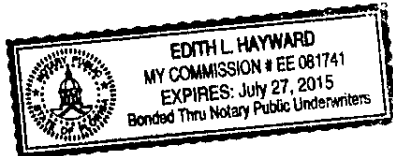


