

TO THE
ARTICLES OF ORGANIZATION

The undersigned, Christine Otto, is the current Managing Member and is being added as Secretary of CUP OF SARASOTA, LLC, hereby certifies that:

1. She is the current Managing Member and Secretary of CUP OF SARASOTA, LLC, a Florida limited liability company, whose Articles of Organization were filed with the Department of State, State of Florida, on June 11, 2012.

2. The following Amendment to the Articles of Organization was unanimously adopted by the Members at a special meeting at which all of the Members were present and voting throughout, duly called for the purpose of adopting this Amendment and held on December 17, 2013.
