ARTICLES OF ORGANIZATION

OF

INVERSIONES TE & ME, C.A. LLC



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **INVERSIONES TE & ME, C.A. LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 8045 Northwest 36th Street, Suite 532A, Miami, Florida 33166 and the mailing address shall be the same.
