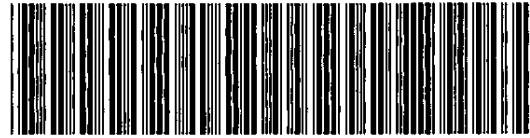




ARTICLE V: Limitation on Agency Authority of Members:
