ARTICLE 1 - NAME

The name of the limited liability company shall be **WORTH AVENUE ACQUISITION FUND LLC** ("Company").

ARTICLE 2 - ADDRESS

ARTICLE 8 - TERMINATION OF EXISTENCE

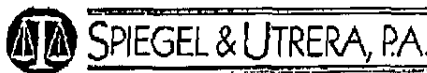

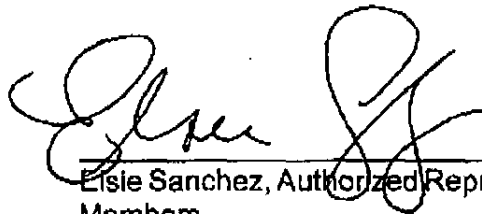

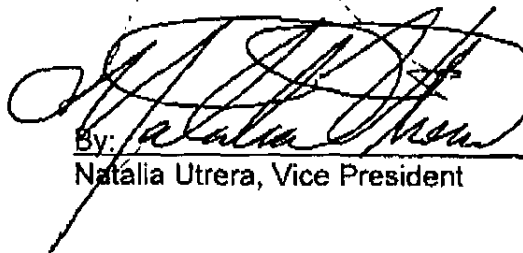
