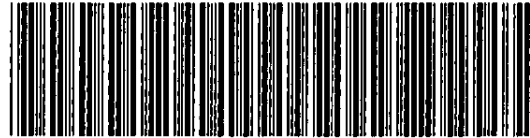



I am in receipt of your letter dated June 5, 2012 regarding the Articles of Organization for BDF, LLC.


