ARTICLES OF ORGANIZATION

OF

The undersigned person, acting as the organizer of GH&G SPRING HILL, LEC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE 1 - NAME

The name of this limited liability company is:

<u>ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS</u>

Any amendment to the Articles of Organization shall be approved by all of the members and shall be as prescribed by the Secretary of State of the State of Florida.
