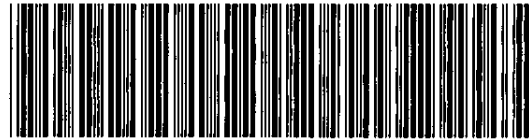


#### ARTICLE 6


