

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
CARRASQUERO PEDIATRICS & ASSOCIATES, LLC**

These Amended and Restated Articles of Organization are submitted in accordance with the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended (the "Act").

ARTICLE I - NAME

The name of this limited liability company (the "Company") is CARRASQUERO PEDIATRICS & ASSOCIATES, LLC.
