ARTICLES OF ORGANIZATION

of

AUL-AFI NORTH AMERICA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME AND ADDRESS

The name of the limited liability company shall be AUL-AFI North America, LLC (the "Company"). PURPOSES AND POWERS

ARTICLE V**TERMINATION OF EXISTENCE**


