That certain Certificate of Conversion for Florida Profit Corporation into Florida Limited Liability Company and Articles of Organization for St. Johns Shipping Co., LLC was filed with the Florida Department of State on June 15, 2012 and assigned Florida document number L12000080226 (the "Original Articles"). These Amended and Restated Articles of Organization (these "Amended Articles") are duly executed and are being filed with the Florida Department of State in accordance with the provisions of Section 608.411 of the Florida Statutes. These Amended Articles shall be effective upon the date of the filing thereof with the Florida Department of State.

Subsequent to the filing of the Original Articles, the original members of St. Johns Shipping Co., Inc. (the "Company") assigned 100% of the membership interests in the Company to Portus Services LLC, and Portus Services LLC has become the sole member of the Company. In connection with the change in the member(s) of the Company, the name of the Company is being changed and these Amended Articles are being submitted to effect such name change and otherwise amend, restate and supersede, in their entirety, the Original Articles as follows:
