NAME**

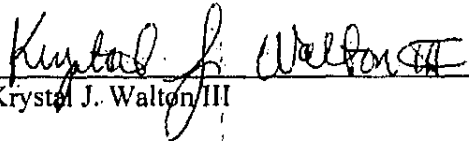
