ARTICLES OF ORGANIZATION  
OF  
PLEASANT ACRES INVESTMENTS, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

ARTICLE I  
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is PLEASANT ACRES INVESTMENTS, LLC.

ARTICLE II  
ADDRESS

The Company's street address of its principal place of business in Florida is 6101 Katrina Drive, Milton, Florida 32570, and its mailing address is the same. The Company shall have the power and authority to establish branch offices at such place or places as may be designated by its Members.

ARTICLE III  
RESTRICTIONS ON MEMBERSHIP

The Members shall have the right to admit new members by unanimous consent. Contributions required of new Members shall be determined as of the time of admission to the Company. A Member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all Members or as otherwise directed in the Company's Operating Agreement.

ARTICLE IV  
OPERATING AGREEMENT

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Members. An Operating Agreement adopted by the Members may be repealed or altered and a new Operating Agreement may be adopted by the Members.

ARTICLE V  
AMENDMENT TO ARTICLES

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions

consistent with Section 608 of the Florida Statutes, as shall be prescribed by the Department of State, and shall be signed and sworn to by all Members of the Company.

ARTICLE VI  
MANAGEMENT

The Company shall be Manager-managed.

The undersigned, being the authorized representative of the Company, hereby acknowledges that, in accordance with Section 608.408(3), Florida Statutes, the execution of these Articles of Organization constitutes an affirmation under the penalties of perjury that the facts stated herein are true.
