LAGGAN, a natural person competent to contract and member of BLCL PROPERTY HOLDINGS, LLC, hereby presents these Articles of Organization as the Articles of Organization of BLCL PROPERTY HOLDINGS, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

**ARTICLE I - NAME**

The name of the limited liability company is:

This limited liability company is referred to in these articles of organization as the "Company."
