ARTICLES OF ORGANIZATION FOR

BMA GEOCONSULTING, LLC

ARTICLE I NAME

The name of this Limited Liability Company shall be **BMA** GEOCONSULTING, LLC (the "Company").

<u>ARTICLE II</u> DURATION
