ARTICLE 1 - NAME

The name of the limited liability company shall be **THE CUSTOMER SERVICE GURUS LLC** ("Company").

ARTICLE 2 - ADDRESS

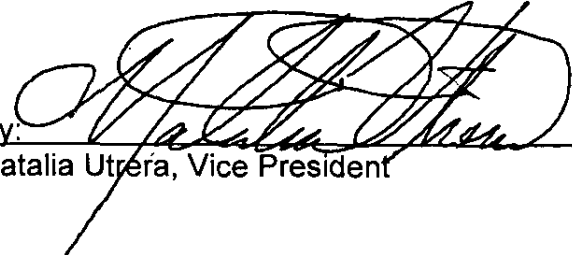
