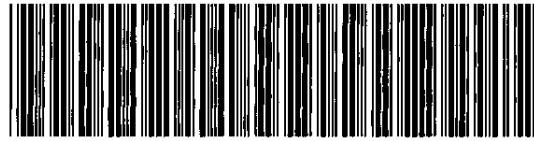

Article III. Initial Registered Agent and Address




