The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is **BAYOU TIGERS ENTERPRISES, LLC**.

**ARTICLE II
ADDRESS**

The Company's street address of its principal place of business in Florida is 550 West Nine Mile Road, Pensacola, Florida 32534 and its mailing address is the same, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Member or Members.

**ARTICLE III
RESTRICTIONS ON MEMBERSHIP**

A Member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all Members.

**ARTICLE IV
OPERATING AGREEMENT**

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Members. An Operating Agreement adopted by the Member or Members may be repealed or altered and a new Operating Agreement may be adopted by the Member or Members.

AMENDMENT TO ARTICLES**


