**ARTICLES OF ORGANIZATION
OF

Pursuant to the Florida Limited Liability Company Act, the undersigned authorized representative submits these Articles of Organization for the purpose of forming Restruck SPB Investor I, LLC (the "Company").

**ARTICLE I
NAME**
