The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I**NAME**

The name of the limited liability company shall be Kalreco, LLC (the "Company"). The mailing address and street address of the principal office of the Company in Florida shall be 2831 State Road 13, St. Johns, Florida 32259.

ARTICLE II**PURPOSES AND POWERS**

ARTICLE V
TERMINATION OF EXISTENCE

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of a majority-in-interest of the members.

ARTICLE VI
MANAGER

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The managers shall be elected in the manner set forth in the Operating Agreement of the Company. The managers shall hold the offices and have the responsibilities accorded to them by the members as set forth in the Operating Agreement. The Company shall exist perpetually.
