

ARTICLES OF ORGANIZATION of THE BAILEY FAMILY SALVATION COMPANY, L.L.C.

The undersigned, being a duly authorized person, desiring to form a limited sliability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I
