**ARTICLES OF ORGANIZATION**

The undersigned, Cynthia S. Tyler, a natural person competent to contract and a member of Kyser Tyler Investment LLC, hereby presents these Articles of Organization as the Articles of Organization of Kyser Tyler Investment LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is Kyser Tyler Investment LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

**ARTICLE III - PURPOSES AND POWERS**

**ARTICLE VI - MANAGEMENT**




