**ARTICLES OF ORGANIZATION
OF
MSL INVESTMENTS, L.L.C.**

The undersigned, desiring to form a limited liability company under the provisions of Sections 608.401 *et seq.*, Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I. Name. The name of the Limited Liability Company is **MSL INVESTMENTS, L.L.C.**

Article II. Principal Office. The mailing address and the street address of the principal office of the Limited Liability Company is **5452 W. CRENSHAW STREET, SUITE NO. 5, TAMPA, FLORIDA 33634**

Article III. Registered Office and Agent. The post office address of the initial registered office of the Limited Liability Company is located within the City of St. Petersburg at **696 First Avenue North, Suite 201, St. Petersburg, Florida 33701**. The initial registered agent is **G.
