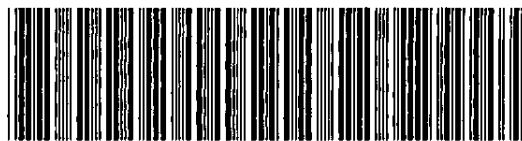

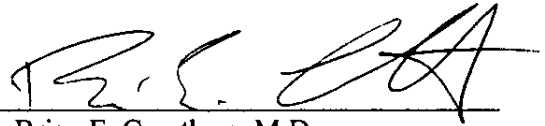
ARTICLE VII
