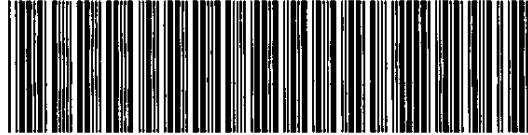

THIRD

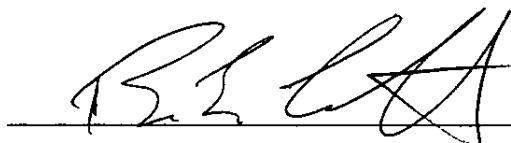
These Articles of Dissolution are being filed because the Company was dissolved by the unanimous written consent of all the Members.
