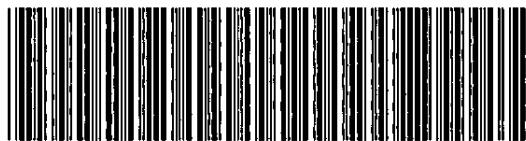



CERTIFICATE DESIGNATING REGISTERED AGENT


