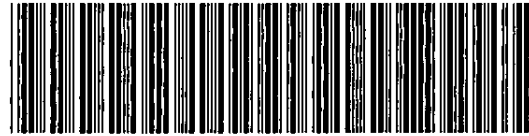

The undersigned, being duly authorized to act as the organizer of this Limited Liability Company, pursuant to Chapter 608, Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company.

ARTICLE I

The name of the Limited Liability Company shall be **Classic A/C Repair, LLC** (hereinafter referred to as the "Company").

ARTICLE II

The principal place of business and the mailing address for the Company shall be:

7320 NW 11th Street
Plantation, FL 33313

ARTICLE III

The purpose for which the Company is organized is to engage in any lawful act or activity for which a limited liability company may be organized.

ARTICLE IV

The term of existence of the Company shall commence with the filing of the Articles of Organization with the Secretary of State of the State of Florida, and shall continue perpetually, unless sooner dissolved in accordance with the laws of the State of Florida and the Operating Agreement of the Company. In no instance shall the Company be automatically terminated, dissolved, or operations suspended upon the occurrence of an event, including the death,

disability, bankruptcy, expulsion or withdrawal of a member of the Company, other than the passage of time as may be specified by law of the Operating Agreement of the Company. Provided, however, that upon any such termination event, the existence and business of the Company may be continued by amendment of these Articles of Organization or the Operating Agreement providing for the continued existence of the Company as may be authorized by Florida Statutes.

ARTICLE V

The exclusive authority to manage the Company is vested in the managers that are appointed by the members, which shall operate in substantially the same manner as, and has substantially the same rights, powers, privileges, duties and responsibilities as a board of directors of a company chartered as a corporation.

No Member of the Company shall be liable for the debts, liabilities or obligations of the Company in excess of the amount of the Member's investment.

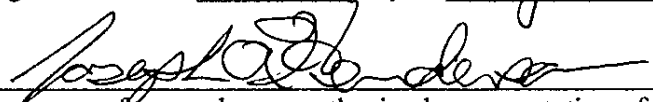
