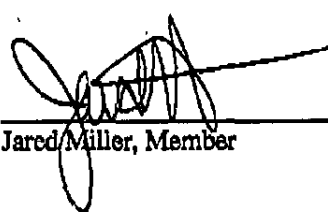
ARTICLE IV

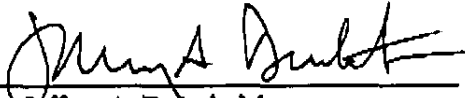
