- Authorize this Company to be a party to any merger, consolidation g. reclassification, reorganization or other similar transaction.

If any Member shall not object in writing to the Manager(s) screquest forconsent pursuant to this Article V within five (5) business days of receipt of such sequest such Member shall be deemed to have consented to the Manager(s)'s request.
