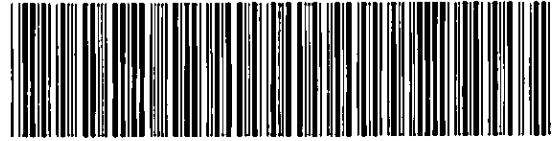

FIRST: The Articles of Organization of the Corporation were originally filed with the Secretary of State of Florida on July 2, 2012, document number L12000087704.

SECOND: These Amended and Restated Articles of Organization, which supersede the original Articles of Organization and all amendments to them, were adopted by the members of the Company on March 4, 2020. To effect the foregoing, the text of the Articles of Organization is hereby restated and amended as herein set forth in full:

ARTICLE II – Address

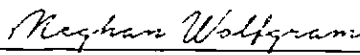
The mailing address and street address of the principal office of the Company is 2955 Lett Ln., Malabar, FL 32950.

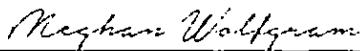
