The name of this Limited Liability Company shall be SRC=SPARKLE RESID. & COMMRC'L CLEANING SERVICES, LLC.


**ARTICLE II-ADDRESS**

**ARTICLE VI- DEBT and CONTRACTUAL LIABILITY**


Any general member may contract debt or incur contractual liability by or on behalf of the Limited Liability Company.
