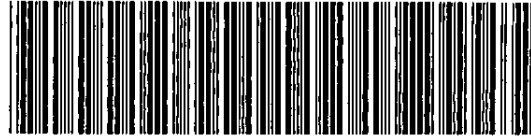

ARTICLE I  
NAME


**ARTICLE VI
