

**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
TKC HOLDINGS, LLC**

The undersigned, a Member of TKC HOLDINGS, LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), states as follows:

1. The name of the Company is TKC HOLDINGS, LLC.
2. The date of the filing of the original Articles of Organization of the Company was July 10, 2012 (the "Original Articles") under Florida Document Number L12000089508. The Original Articles were amended pursuant to an Amendment to Articles of Organization filed with the Secretary of the State of Florida on August 24, 2012 (the "Amendment to Articles"). The Original Articles and the Amendment to Articles are hereinafter referred to as the "Articles of Organization".
3. Article V of the Articles of Organization is hereby amended as follows:
