## ARTICLES OF ORGANIZATION OF 3424 EDGEWATER DRIVE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be 3424 EDGEWATER DRIVE, LLC, a Florida limited liability company ("company").

#### **ARTICLE II - ADDRESS**
