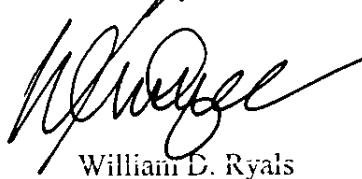

MANAGEMENT

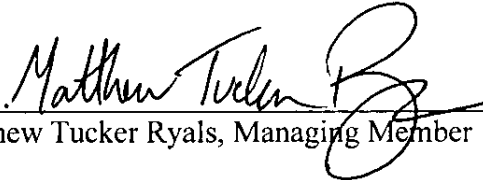
The Company is to be managed by a manager who is designated to act as the managing member in accordance with the Operating Agreement of the Company.
