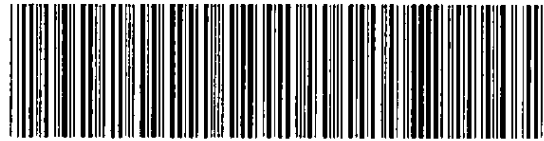

SIXTH: If other than the date of filing, the delayed effective date of the merger, which cannot be prior to nor more than 90 days after the date this document is filed by the Florida Department of State is April 1, 2023 (the "Effective Time").


SEVENTH: At the Effective Time, (i) all of the estates, properties, rights, privileges, franchises, causes of action and every other asset of the merging parties shall immediately, by operation of law and

without any conveyance, transfer or further action, become the property of the surviving party. (ii) each member interest in the merging parties shall automatically be canceled and retired and shall cease to exist, and no consideration shall be delivered in exchange thereof, and (iii) the surviving party shall be deemed to be a continuation of the merging parties and shall succeed to the rights and obligations of the merging parties and the duties and liabilities connected therewith. The surviving party shall receive the stock of any Brazilian legal entity for the same value held by the merging parties equal to their equity registration in Brazil.


