OF

THE UNDERSIGNED hereby certify that he intends to form a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. A Member's interest in the Company shall not be transferred unless the transfer is approved by the Members in accordance with the Company's Regulations.

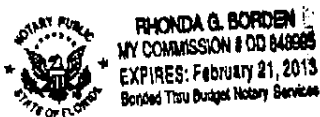
