ARTICLE III - Management

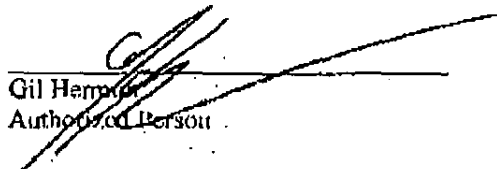
The Company shall be managed by its member, as set forth in the company's Operating Agreement, and is therefore a member-managed Company.
