## ARTICLES OF ORGANIZATION OF IMC OF OKLAHOMA, LLC

The undersigned authorized representative of one or more members, for the purpose of forming a limited liability company ("Company") pursuant to the Laws of the State of Florida, and particularly Chapter 608, Florida Statutes, hereby submits the following Articles of Organization:

#### Article 1 Name

The name of the Company shall be IMC of Oklahoma, LLC. These Articles of Organization may be referred to as the "Articles", and the Operating Agreement of the Company may be referred to as the "Operating Agreement."

#### Article 2 Office

The Company shall have perpetual existence.
