The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 1 - NAME

The name of the limited liability company, hereinafter "Company" shall be **QUALITY SHAVINGS OF SOUTH FLORIDA LLC**.

#### ARTICLE 2 - ADDRESS

The initial principal place of business of the Company in Florida shall be: 7800 N. University Drive, Suite 304, Tamarac, FL 33321.

#### ARTICLE 3 - EFFECTIVE DATE

The effective date of these Articles of Organization shall be upon the filing of these articles of organization.

#### ARTICLE 4 - DURATION

# ARTICLE 6 - REGISTERED AGENT

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of the remaining members, provided there are at least one remaining member.

# ARTICLE 11 - INDEMNIFICATION AND INSURANCE

advance expenses to any such person by contract or n any other manner. If any word, clause or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees or expenses shall be held invalid as contrary to law or public policy, it shall be severable and the provisions remaining shall not be otherwise affected. All references in these Articles of Organization to "member", "manager", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons
