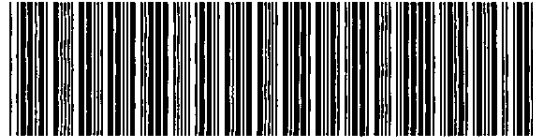

ARTICLES OF ORGANIZATION
OF
B & B LAND COMPANY OF ROCKLEDGE, L.L.C.

The undersigned, acting as the organizers of this Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company:

ARTICLE I - NAME

The name of the limited liability company shall be **B & B LAND COMPANY OF ROCKLEDGE, L.L.C.** (the Company).

ARTICLE II - ADDRESS OF PRINCIPAL OFFICE

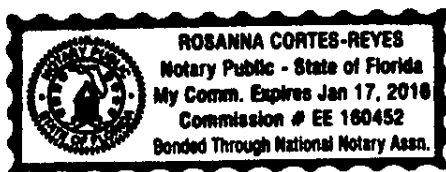

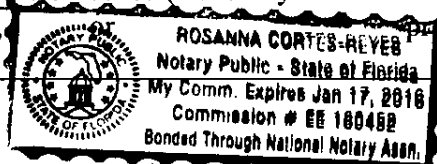
