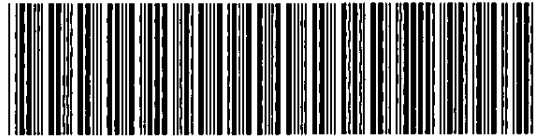

**ARTICLES OF ORGANIZATION
FOR
STEFAS 165, L.L.C.
A FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE I - NAME

The name of the Limited Liability Company is: **STEFAS 165, L.L.C.**

The regulations of this limited liability company may only be adopted, amended, altered or repealed by the unanimous vote of the members.


ARTICLE IX - MEMBERS' RIGHT TO CONTINUE BUSINESS


