

ARTICLES OF ORGANIZATION FOR STEFAS 2079, L.L.C. A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I - NAME

The mailing address and the street address of this limited liability company shall be 18460 N.E. 23rd Court, North Miami Beach, Florida 33160.


ARTICLE V - INITIAL REGISTERED AGENT AND OFFICE
