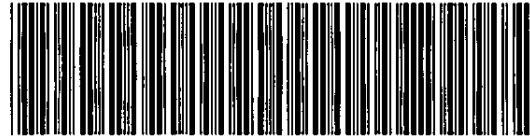

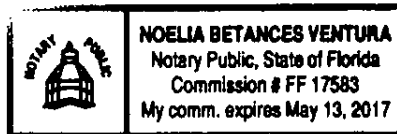

Amendment to LLC Agreement

4. **Frank Albert** and **Justin Jones** have had sufficient time to review this agreement.
5. **Frank Albert** and **Justin Jones** have both willingly and voluntarily entered this Agreement and have not been forced by either party or anyone else to sign this Agreement.
6. **Frank Albert** and **Justin Jones** are confirming they are in sound mental health. They believe, to the best of their knowledge, the other party is also in sound mental health.
7. **Frank Albert** and **Justin Jones** have no knowledge of any open loans, lines of credit, or unpaid liability other than the loan between Green Home Design, LLC and NICOLETTA NASTARI.
8. **Frank Albert** and **Justin Jones** are agreeing to the amendment, that will allow Green Home Design, LLC to remove a manager. The removed manager will be Frank Albert.
9. **Frank Albert** and **Justin Jones** are agreeing to sign all necessary documents, to allow Green Home Design, LLC to remove Frank Albert as a manager of Green Home Design, LLC.
10. **Frank Albert** will no longer be responsible for any business needs of Green Home Design, LLC. **Justin Jones** will remain as the lone manager of Green Home Design, LLC and will be responsible for all future business needs.
11. **Frank Albert** is released from any future financial obligations and liability that may arise out of Green Home Design, LLC. **Justin Jones** will solely be responsible for future financial obligations of Green Home Design, LLC.
12. **Frank Albert** and **Justin Jones** agree that all assets of Green Home Design, LLC have been accounted for and divided.
13. **Frank Albert** and **Justin Jones** agree that neither party is owed any compensation after this agreement.
14. **Frank Albert** agrees to remove his name from all checking and savings accounts associated with Green Home Design, LLC. Justin Jones agrees to remove Frank Albert from insurance policy, leases, and any other paperwork with his name on it.
15. **Frank Albert** has received cashier check #5501436090 in the amount of \$10,000.00 from Justin Jones as payment for this separation.
16. **Frank Albert** has received cashier check #5501436089 in the amount of \$3,129.00 from joint checking, Green Home Design, LLC / Frank Albert & Justin Jones, account #0135676418 as payment for his final share of business assets.

These terms above are effective immediately once this agreement has been signed by both parties.
