ARTICLES OF ORGANIZATION
OF
CENTRAL FLORIDA ALTERNATIVE RENEWABLES, LLC

The undersigned, as the authorized representative of CENTRAL FLORIDA ALTERNATIVE RENEWABLES, LLC, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is CENTRAL FLORIDA ALTERNATIVE RENEWABLES, LLC.

ARTICLE II
ADDRESS

The Company's street address of its principal place of business in Florida is 120 E. Main Street, Suite A, Pensacola, Florida 32502, and its mailing address is the same, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

ARTICLE III
MANAGEMENT

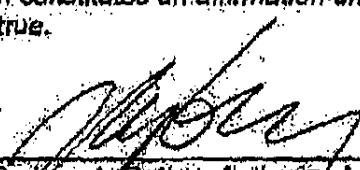
ARTICLE VI

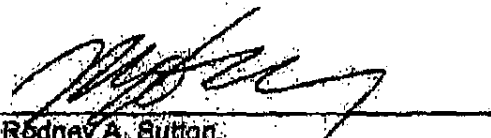

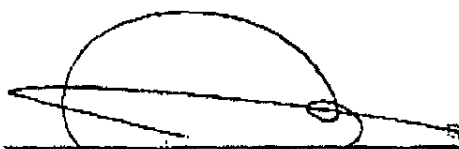
