The mailing address and principal place of business of the Company is 2665 South Bayshore Drive, Suite 220, Coconut Grove, FL 33133.

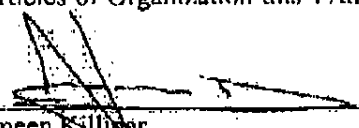
**ARTICLE III

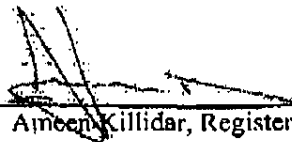
